

1. The "Win Your Entry Fees Back Competition" (**Competition**) is organised by Paddle Australia (**Organiser**). By participating in this Competition, you (**Participant**) agree to be bound by these Terms and Conditions.
2. The Competition is open to individuals who are 15 years of age or older at the time of entry. Employees, representatives, or agents of the Organiser, as well as their immediate family members, are not eligible to participate in the Competition.
3. To enter the Competition, Participants must complete the following steps before 17 July 11:59 pm AWST.
 - a. Purchase an entry fee for the 2023 ICF Canoe Ocean Racing World Championships (**World Championships**) or 2023 ICF Canoe Ocean Racing Masters Championships (**Masters Championships**);
 - b. Ensure that the entry fee payment is made successfully through the Paddle Australia JustGo Entry Portal;
 - c. Provide all relevant details required during the entry process accurately and completely; and
 - d. Meet all the requirements and eligibility criteria in the [ICF Canoe Ocean Racing rules \(Rules\)](#) to be a valid entrant in the competition.
4. The Participant's entry into the Competition will only be considered valid if all the steps outlined in point 3 above are completed within the specified deadline.
5. By entering the Competition, Participants agree to comply with the rules and regulations of the relevant Championships and any additional requirements determined by the Organiser.
6. The winners of the Competition will be selected through random draws. One winner will be drawn once per fortnight in the lead up to 17 July. Winners will be notified via the contact information provided during the entry process.
7. The prize for each draw is a refund of the entry fees paid by the Participant for the World Championships or Masters Championships. Other expenses, including but not limited to travel, accommodation, and equipment, are not included in the prize.
8. The prize is non-transferable and cannot be exchanged for cash or any other alternatives.
9. If a selected winner fails to respond within 7 days of receiving the notification, or if the Organiser determines that the winner did not meet the requirements and eligibility criteria in the Rules, the Organiser reserves the right to disqualify that winner and select an alternative winner through a subsequent random draw.
10. The Organiser reserves the right to disqualify any entry that is deemed inappropriate, fraudulent, or violates these Terms and Conditions or the rules and regulations of the relevant Championships in any way.
11. By participating in the Competition, Participants grant the Organiser the right to use their name and likeness for promotional purposes related to the Competition and future events, without any further compensation.
12. The Organiser is not, shall not be held, responsible for any technical malfunctions, interruptions, or errors that may occur during the entry process or the selection of the winners.
13. The Organiser reserves the right to modify, suspend, or terminate the Competition or these Terms and Conditions at any time without prior notice, for any reason.
14. These Terms and Conditions are governed by and construed in accordance with the laws of the jurisdiction in which the Organiser is based.
